FAA PART 139 CERTIFICATION INSPECTION

- FAR Part 139 serves to ensure safety in air transportation and defines the standards within which an airport must operate on a daily basis. This comprehensive periodic airport inspection was conducted January 11-13, 2016 and focused on areas such as: condition of runway and taxiway pavement, marking, and lighting; accuracy of records for facility self-inspections; training of personnel and aircraft fueling operations. Inspectors also critique the Airport's Certification Manual – a comprehensive document that includes an emergency plan for a variety of operational scenarios, including a night inspection, evaluating runway, taxiway and apron lighting and signage, pavement marking, airport beacon, wind cone, lighting, and obstruction lighting for compliance with Part 139 and the ACM/ACS.

During the post inspection briefing with airport management the FAA would discuss any findings, issue Letter of Correction noting violations and/or discrepancies, if any are found, agree on a reasonable date for correcting any violations, and give safety recommendations. I am proud to announce that VGT passed with "No Findings." The VGT staff continues to do an outstanding job maintaining the airfield and complying with all fueling regulations. I would like to thank my staff for their efforts and dedication. In addition I would like to thank the Las Vegas Fire & Rescue Department and North Las Vegas Fire Department for meeting and exceeding all the Aircraft Rescue and Fire Fighting (ARFF) training requirements of the FAA.

REMINDER – "VEHICLE/ GROUND SUPPORT EQUIPMENT OPERATIONS

– "No person shall operate or park any vehicle on the AOA for any General Aviation Airport unless the vehicle is currently registered with the DOA and properly identified. All vehicles designated to operate on public streets shall be subject to the licensing of the State of Nevada. Any vehicle not designated to operate on public streets shall meet the Safety requirements in place at the time of manufacture. All vehicles operated on the AOA between civil twilight and civil sunrise shall display either headlights and taillights or a yellow beacon in a prominent position. Vehicles are permitted to be driven in the Airport Non-Movement Area without the permission of the Director, or designee. Any person operating a vehicle on any General Aviation Airport shall comply with all DOA Rules and Regulations, Operating Directives, and posted restrictions."

Only authorized vehicles with decals are allowed on the airfield, all others are subject to being towed at the owner's expense. If you have not been issued a vehicle decal, please stop by the VGT Administration

Office during business hours to obtain your vehicle decal.



HANGAR IMPROVEMENTS-

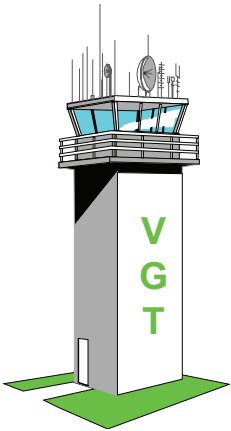
Any improvement to your hangar or commercial facility must receive approval from the DOA before proceeding. The Business Office will complete a Project Concept Approval form based on your complete project description and concept drawing (e-mail to kellybu@mccarran.com or submit to the office).

Please plan ahead because the process can take up to four weeks. Your contractor will work with the DOA Project Coordinator and Inspector to complete the Project Acceptance Checklist. When all checklist items have been completed, DOA Construction/Engineering will confirm that all issues have been completed before closing the project. DOA will respond to your request as soon as possible (may take a few weeks based on the complexity of the project). A Project Coordinator will be assigned to assist you and a pre-construction kick-off meeting will be scheduled. During construction, the contractor will work with the DOA Project Coordinator and Inspector to complete the Project Acceptance Checklist. When all checklist items have been completed (including the submission of As-Builts), DOA Construction/Engineering will confirm that all business/acquisition issues have been completed before closing the project.
