

NORTH LAS VEGAS AIRPORT EMERGENCY CONTINGENCY PLAN

North Las Vegas Airport has prepared this Emergency Contingency Plan pursuant to §42301 of the FAA Modernization and Reform Act of 2012. North Las Vegas Airport is filing this plan with the Department of Transportation because it is a commercial airport.

This plan describes how, following excessive tarmac delays and to the extent practicable, North Las Vegas Airport will:

- Provide for the deplanement of passengers (ramp debarking only – no loading bridges available);
- Provide for the sharing of facilities at the airport; and
- Provide a sterile area following excessive tarmac delays of passengers who have not yet cleared United States Customs & Border Protection (CBP).

North Las Vegas Airport Facility constraints that limit our ability to accommodate diverted flights or maintain the airport's safe operation and strongly encourage aircraft operators to contact the airport at (702) 261-3800 for prior coordination of diverted flights, except in the case of a declared emergency. Specific facility constraints include the following: No loading bridges, lack of international passenger processing facilities, limited number of aircraft parking positions, inability to accommodate park or service certain types of aircraft, and limited fueling capacity. We have noted these constraints in the North Las Vegas Airport/Facility Directory record. During diversion events North Las Vegas Airport issues NOTAMs regarding its ability to accommodate diverted flights to ensure the safe and efficient operation of the airport and its ability to serve the civil aviation needs of the public during irregular operations events.

Plan to provide for the Deplanement of Passengers Following Excessive Tarmac Delays

North Las Vegas Airport does not own or operator any of the equipment needed to safely deplane passengers from air carrier aircraft and is, therefore, unable on its own to provide for the deplanement of passengers. Additionally airport personnel are not trained to assist in the deplanement of passengers using equipment owned or operated by air carriers or contract service providers. We will provide a list of airlines, ground handlers, fixed base operators and others who may have the necessary equipment and personnel to safely deplane passengers to airlines as soon as practicable after receiving requests from such airlines experiencing excessive tarmac delays at the contact number listed above. North Las Vegas Airport operates the FBO and can accommodate fueling, towing, ground power/engine starts and lavatory servicing. North Las Vegas Airport will provide vans to facilitate the transportation of passengers from remote locations to the terminal building.

Plan to Provide for the Sharing of Facilities and Make Gates Available in an Emergency

The gate at North Las Vegas Airport are under exclusive lease to air carriers and are not controlled by the airport during those time periods when the tenant airline is using or scheduled to use the gates. We are unable to direct a tenant airline to accommodate another air carrier aircraft at its exclusively leased gate during those time periods when the gate is in use or scheduled to be in use. We will direct our tenant air carriers to make gates and other facilities available to an air carrier seeking to deplane at these exclusively-leased gates during those times periods the gates are not in use or not scheduled to be in use, to the maximum extent practicable.

Plan to Provide a Sterile Area for Passengers Who Have Not Cleared United States Customs and Border Protection

North Las Vegas Airport does not have international passenger processing facilities. We will coordinate with the local CBP and law enforcement officials to identify suitable areas and procedures for establishing a temporary sterile area into which international passengers on diverted aircraft who have not yet cleared United States Customs and Border Protection can be deplaned. Once these efforts are complete, we will coordinate with local CBP officials to develop procedures that will allow international passengers who have not cleared United States Customs and Border Protection to be deplaned into these sterile areas to the extent practicable.
